These terms and conditions apply to the viewing, purchasing and sale of products through www.uline.ca (the “site”), a site operated by Uline Canada Corporation (“Uline”). By viewing this site, placing an order or completing a purchase, you agree to be bound by and accept these terms and conditions. If you do not agree to these terms and conditions, do not use this site and do not place an order. Please print a copy of these terms and conditions for your records. All advertisements on the site are invitations to purchase and not offers to sell. Uline reserves the right, at its sole discretion, to accept or reject the order once the order has been completed and submitted by you.

Pricing and Specifications

All information regarding pricing, products and services is subject to change. Uline reserves the right to make adjustments to pricing and products for reasons including, but not limited to, changing market conditions, discontinuation, unavailability, manufacturer price changes and errors in advertisements.

Prices listed are net and do not include shipping charges, handling fees, taxes and/or applicable duties, brokerage fees or special crating requirements for export shipment. Those customers who claim exemption from taxes or duties are responsible for providing Uline with the necessary documentation at the time of purchase or taxes will be added to their order. Uline always strives to maintain low prices. Occasionally, stated prices on the site are subject to change without notice due to circumstances beyond our control.

Shipping

Most products are shipped F.C.A. point of origin from the nearest Uline warehouse to your location. UPS is used whenever possible. However, should your order exceed UPS size or weight limits, “Common Carrier” will be selected to expedite delivery. For rush shipments, please request Fed Ex, UPS Air; Next Day, 2nd or 3rd day or Freight Collect. All shipping charges are prepaid by Uline and added to the customer’s invoice unless you choose to be billed freight collect. A \$1.50 handling fee will be added to shipping charges. Any additional charges for services requested by the customer, including but not limited to inside delivery, special routing, residential delivery or pre-delivery notification must be paid by the customer.

Inside Delivery

Please specify if you need inside delivery when placing your order. UPS does not charge for this service. However, there may be a charge when using a freight carrier.

Returns

If for any reason you are dissatisfied with a purchase you made from Uline, you may return the merchandise within 30 days. Please contact customer service at 1-800-295-5510 for an authorization number or complete the form on the back of the packing list and return the merchandise within 30 days. Customers will be responsible for shipping charges on cancelled orders. Due to their nature, custom and made-to-order products cannot be accepted for return unless the product was initially defective.

If a product is damaged during delivery to you via a freight carrier, note the damage on the carrier's delivery receipt and request an inspection report on the damaged shipment from the carrier to be forwarded to you within 10 business days. Forward the inspection report and original packing list to Uline and we will file a claim on your behalf and immediately replace the damaged item(s).

If a product is damaged during delivery to you via UPS or Parcel Post, you must note the extent of the damage on the back of the packing list. Once complete, forward the form to Uline and hold the damaged materials for disposition instructions.

Warranties

Customers acknowledge that Uline is not the manufacturer of any of the products purchased hereunder. Any warranty with respect to the products must come from the manufacturer. Uline will pass through to customers any applicable warranties of the manufacturer, if any, to the extent permissible. Notwithstanding anything to the contrary, Uline's liability is limited to the replacement value of the products purchased from this site.

Uline and its affiliates hereby expressly disclaim all warranties and conditions, either legal, express or implied, arising from statute, course of dealing, usage of trade or otherwise, related to this site or the products, including, without limitation, any warranty of merchantability, merchantable quality, quality or fitness for a particular purpose, or warranty of non-infringement. This disclaimer does not affect the terms of the manufacturer's warranty, if any.

Payment Terms

For those customers with established Uline credit, payment terms are net 30 days from the date of invoice. In addition, Uline accepts all major credit cards at the time of order. COD is only available for those orders picked up at a Uline warehouse. If paying by credit card, you hereby authorize Uline to charge the applicable card the full amount payable for your order and you represent and warrant that you are the cardholder of the applicable card. If your card is rejected by the card issuer, your order will not be shipped and Uline will have no obligation to fulfill your order.

Applicable Law

This site is controlled by us from our offices within the Province of Ontario, Canada. By accessing this site you agree that the laws of the Province of Ontario, without regard to conflicts of laws principles, will apply to all matters relating to the use of this site and the purchase of products available through this site.

The parties hereby expressly exclude the application of the United Nations Convention on Contracts for the International Sale of Goods.

Entire Agreement
